3. The Trustees shall pay or utilize the net income of the TRUST Fund for all or any of the following charitable purposes in such shares and proportions and in such manner as the Trustees in their discretions think fit and Proper.

HEALTH AND HUMAN SERVICES:

1. To establish open and /or manage dispensaries, Hospitals, conduct medical camps , provide medical facilities ,etc.. to the common public with focus on poor and weaker sections of the society.
2. To provide relief and assistance, medical care to HIV affected person in the rural industrial and slum areas. -
3. To arrange for medical camps seminars, for the treatment welfare and awareness of the public regarding several diseases like ,AID, CANCER, DIABITIES , ALCHOLISIM and DRUG,ADDITION etc.
4. To make readily available cost-effective, quality health care at the doorstep of rural India.
5. To organize diabetes detection camp at regular intervals in rural area and provide free medical treatment for eligible patients.


CIVICS:

1. To help the ages above 60years for their livelihood medical treatment and provide conditions of security and caring and old age nursing homes .
2. To support the women in developing their economics capabilities as a support to their children and family.
3. To freely supply and support to the eligible and solely depending hand-cart vendors in the urban and semi- urban for their economic sustenance .
4. To provide relief to the victims of natural calamities ,to help and co-operate the relief activities related to flood ,earth quake , ,epidemic drought etc.
5. *There are no immovable properties involved in the TRUST. as on date.*

ENVIRONMENTAL:

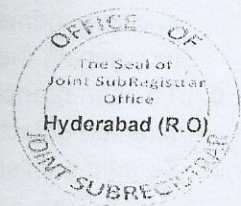
1. To grow different kinds of herbal medicines through preservation of different categories of species, conservation preservation and different kind of medical gardens for it . Construction of green house etc., for the promotion and conservation of herbal medicine a co-operative institution will be formed for the farmers to sow herbal medicines.
2. To do research and spread the uses of non conventional energies like biogas like biogas solar energy, Gobar gas particularly in rural area.
3. To prepare a plan for the conservation and prevention of national natural resources, water, increasing the fertility of land tree plantations , maintaining ecological balance ,Greenery and sowing of herbal and mass movement to encourage people to do this .
4. To reduce the green House -gas emissions increase recycling and energy efficiency, and to protect and restore critical natural assets and habitat.
5. To Raising of funds, accepting donation and gifts to realize these goals .to do business and arrangement of loans from different financial institutions. Loans from banks and mortgaging the assets to re- pay the loan.
6. To open branches wherever considered expedient for the promotion of above service oriented objectives of the TRUST.
7. To print publish , start ,conduct and issue any book ,pamphlets, posters and magazines , periodicals and news papers that may be considered desirable for the promotions of objects of the TRUST.
8. To raise money from any of the above objects or Purpose by mortgaging of or charging all or any such property as may legally be mortgaged for charged with capital sum.
9. To acquire by gifts ,purchase ,exchange , lease or hire or otherwise any lands, building, play grounds, parks ,and other movable or immovable property and construct maintain buildings for the purpose of the TRUST
